FOOD VENDORS NOTICE

NASSAU COUNTY HEALTH PERMIT REQUIRED FOR ALL FOOD VENDORS

All food vendors need to secure a 'Special Event Permit' from Nassau County Department of Health.

All food and drink concessions accompanying carnivals, circus, fair, exhibition or special event for purposes of public gatherings for a period greater than 24 hours or if attendance is expected to exceed 500 persons, requires a special event permit issued by the Nassau County Department of Health. An application for a special event permit must be submitted to Nassau County Health Department at least 30 days prior to the scheduled event.

All food and drink concession accompanying such events are by definition, Temporary Food Service Establishments. As such, they are governed by the regulations of Sub-part 14-2, New York State Sanitary Code, and are required to obtain and display, a valid food establishment permit issued by the Nassau County Department of Health. Non-profit religious and charitable organization sponsoring the affair are exempt from the fee for self-operated concessions but not from the requirement for a food establishment permit.

It is the sponsor's responsibility to provide the names of all concessionaires and to ensure that an application for each food concession permit is submitted to this Department at least three (3) business days prior to the scheduled opening of the event. Any establishment failing to obtain a valid food establishment permit will be enjoined from operating at the event.

The issuance of the special permit to operate a carnival, circus, bazaar, exhibition or special event, which is separate and apart from the food establishment permit, is contingent upon satisfactory compliance with all the requirements.

3. Vendors will be accepted on first come first serve basis. Organizers do not promise any exclusivity.
4. The organizers reserve the right to assign booths to vendors. Vendors will not be allowed to select or change the assigned location of their booth.
5. Booth size measure approximately 10' X 10' and come with **one 6' table and one chair**. Additional tables/chairs are available for \$20.00 only if pre-ordered by October 10, 2017.
6. The event timings are 12:00 to 8:00 PM. Booths must be completely set by 11:00AM.
7. Electrical power and Internet access are **NOT provided** by the organizers. Vendors are responsible for making their own arrangements with proper prior Nassau County and Town of Oyster Bay approvals.
8. Vendors (Food and non-food) are responsible for all permits required for street fairs at their own cost and responsibility from Department of Health and Department of Consumer Affairs, Nassau County. All permits should be obtained at least two days before the event.
9. Food vendors are required to adhere to all the requirements of the Department of Health, Nassau County. All food vendors are required to have their own fire extinguisher with current inspection tag.
10. Vendors are responsible for cleaning their booths and disposing garbage at the assigned location. The refundable deposit of \$50.00 will only be refunded upon returning the tables, chairs and the booth area in a clean condition. **(NO EXCEPTIONS)**
11. The organizers do not guarantee a minimum turnout and are not responsible for inadequate turnout.
12. Event sponsors and vendors authorize the organizers to use their respective names and logos in all promotional materials and broadcasts.
13. Vendors are **restricted** from selling or distributing alcoholic beverages, narcotics, fireworks, arms and ammunition (including guns etc) at the event. Other restrictions may apply.
